MANAGEMENT COMMENTARY

The month-on-month performance for Sub-Fund 3 in November 2020 was + 0,46 % and for Sub-fund 4 + 0,47 %, in line with the target.

There were no major changes in the structure of the underlying portfolio during the month. The fund manager decided to halt subscriptions and redemptions of shares for another period of 3 months, starting 01.11.2020 until 01.02.2021. The primary reason for this decision are ongoing financial difficulties of Arca Investments, a. s. in Slovakia. The fund manager's decision is meant to protect the interests of investors and the value of their shares.

INVESTMENT STRATEGY

The underlying assets of both sub-funds are loans provided for a specified purpose. Among other projects, a large portion of the portfolio is the financing of a microfinance institution providing short and medium-term retail loans.

INVESTMENT GOAL

The investment objective of both sub-funds is to generate a stable quarterly income through investing and co-investing in projects capable to deliver a continuous and sustainable cash flow. The sub-funds can pay a regular quarterly advance on dividends based on the decision of the fund management company.
