## MANAGEMENT COMMENTARY

In May 2021, the NOVA Green Energy fund appreciated by 0.36%, recorded its slightly below-standard monthly performance, and thus continues the growth trajectory. We confirm the strong foundation of the underlying assets and the prospect of investing in renewable energy sources. The appreciation of the fund since the beginning of the year is thus a total of +2.02%. The production of photovoltaic power plants has been below the value of the energy audit since the beginning of the year, specifically in May it was 96%. The biogas stations and the biomass heating plant in Krnče were at their expected average.

The new photovoltaic project in Csabrendek, Hungary, with an output of 28.5 MW is fully under the control of the fund. The construction site was handed over to the general contractor, the German group GreenCells, while the installation of panels and laying of cables was started, and overall, the construction continues in accordance with the schedule. The financing of the project was secured in the form of a senior bank loan and the final steps leading to the drawing of individual tranches of the loan are now underway.

On the roof of the Orlice shopping center in Hradec Králové, we plan to implement a photovoltaic power plant even without the considered subsidy, as market prices of electricity and emission allowances are at their long-term historical highs, which prepares space for these sources in the future on a purely market basis. In this direction, we will start preparatory and design works in summer.

The projects of the two biomass heating plants, the secured receivables of which also form the assets of the sub-fund, are working as expected. Following the crystallization of the situation with Arca Capital, we will communicate with the financing bank regarding the approval of the transfer of both energy sources to the sub-fund's assets, which would allow unblocking the valuation discount due to above-average production parameters. with a coronavirus pandemic. It is also possible to fully repay the fund's receivables to a new strategic investor, which would allow us to enter into new, already analyzed projects in Poland or France.

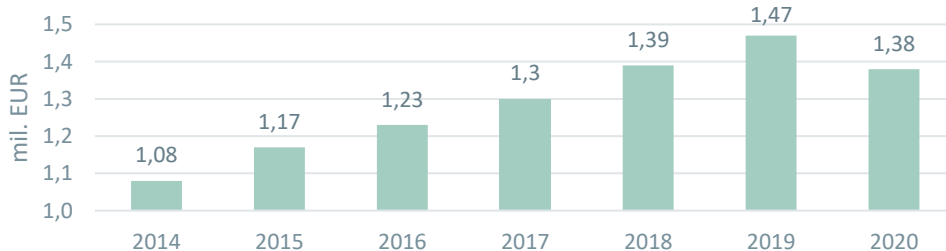

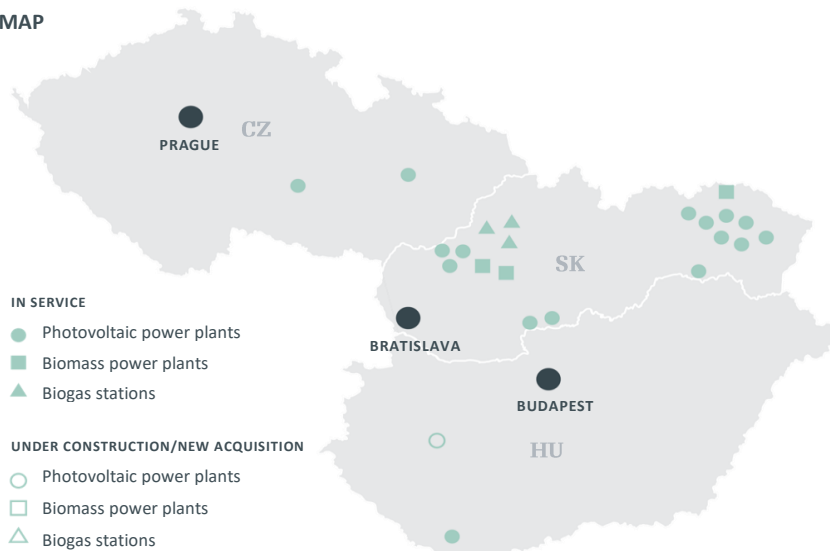
