In December 2021, Sub-Fund 1 NOVA Green Energy appreciated by 0.28%, for the whole of 2021 it achieved an overall appreciation of + 4.62 % and achieved a slightly below-average annual performance. From the point of view of the fundamentals of individual energy sources, the fund reached the expected level, with assets related to the Arca Group and biogas plants in Slovakia having a negative impact.

In November, on which the December award is based, the level of energy audit reached its level and, cumulatively for the first eleven months of this year, it also reaches the expected average. Restructuring of biogas plants will be decided in the coming months, the key position being the financing banks. The biomass heating plant in Krnč is back in operation after technical problems with outages.


The construction of the largest photovoltaic project in Csabrendek, Hungary, with an output of 28.5 MW is nearing completion, the power plant was successfully approved at the end of the year, and the final finishing work is underway, which will lead to the final acceptance of the work. The financing of the project was secured in the form of a bank loan and the first tranches of the loan have already been drawn.

The projects of two biomass heating plants, whose secured receivables also form the fund's assets, are facing an increase in the price of the input raw material (wood chips) and are under the production and operating plan. We solve the whole situation comprehensively and on a longterm basis with both Arcy's management and the bank's financing. We are currently awaiting approval of the revised Arca Capital Slovakia restructuring plan. After clarifying the position of the creditors' meeting, we will proceed to evaluate the potential impact on the fund's assets. The next step of the fund with regard to the protection of fund assets will also depend on this step.

Overcompensation and solar tax on PV were approved in the Czech Republic by the Senate and the Chamber of Deputies, approval of the implementing decree is expected around March 2022, then it will be possible to determine purchase prices of two power plants in the Czech Republic In Slovakia, the price proposals of the PV portfolio were approved, and the analysis of the impact of these changes on the value of PV projects in the fund will be taken into account in an independent expert opinion at the end of 2021.
