

The new photovoltaic project in Csabrendek, Hungary, with an output of 28.5 MW is fully under the control of the fund. The construction site was handed over to the general contractor, the German group GreenCells, while the deliveries of panels were completed and now the reconstructions, earthworks, etc. is in progress. Financing of the project is secured with the bank in the form of a senior loan.


On the roof of the Orlice shopping center in Hradec Králové, we plan to implement a photovoltaic power plant even without the considered subsidy, as market prices of electricity and emission allowances are at their long-term historical highs, which prepares space for future operation of these sources purely on a market basis. In this direction, we will start preparatory and design work in the coming weeks.

The projects of the two biomass heating plants, whose secured receivables also form the assets of the sub-fund, are working as expected. Following the crystallization of the situation with Arca Capital, we will communicate with the financing bank regarding the approval of the transfer of both energy sources to the sub-fund's assets, which would allow unlocking the valuation discount due to above-average production parameters. with a coronavirus pandemic. It is also possible to fully repay the fund's receivables to a new strategic investor, which would allow us to enter into new, already analyzed projects in Poland or France.
